COMPREHENSIVE EXAMINATION

The comprehensive examination assesses whether a student possesses the requisite knowledge and capacity to earn a Master in European Studies degree - Comparative Regional Relations of Asia and Europe.

- Upon satisfactory completion of all academic units (i.e., required courses and field of concentration), the student will formally apply to take a comprehensive examination covering all of the required courses except for EU 225 (Research Methods and Designs in Regional Studies), and EU 298. The examination consists of the following:
 - Part I: EU 205 and 210
 - Part II EU 215 or EU 220 plus Field of Concentration
- The student must take both Parts in the comprehensive examination in two scheduled sittings.
- Electives will be taken by the student after passing the comprehensive examination.

EU 298 - RESEARCH PAPER (3 UNITS)

The student is required to write a Research Paper on issues relevant to the ASEAN and the EU, including Philippine relations on both regional blocs.

- a. The student must enroll EU 298 (Research Paper) after he/she passed the comprehensive exam.
- b. A pre-requisite course for the Research Paper is EU 225 (Research Methods and Designs in Regional Studies). The expected output for EU 225 is an approved research proposal. The research proposal in EU 225 will serve as an outline of the Research Paper.
- c. The final draft of the Research Paper will be presented to a reader with field of expertise. The student obtains three (3) units of credit upon approval of the Program and submission of the final paper.

CERTIFICATION IN A BASIC MODERN EUROPEAN LANGUAGE

- a. In order to complete the degree, students will need to obtain A2 level of language proficiency in any of the following European languages: French, German, and Spanish.
- b. The certification is obtained by passing the recognized A2 level test given by the cultural institutes of France, Germany, and Spain. The French Exam (DELF) is administered by the Alliance Française de Manille, the exam in German (Goethe-Zertifikat) can be taken at the Goethe Institut, and the Spanish Exam (DELE) is given by the Institute Cervantes.
- c. The Department of Modern Languages may offer extramural classes to students taking the MA European Studies and Masters in European Studies, in preparation for the language proficiency exam given by the cultural institutes.
